1975 Team Trials - Postal

I apologise for the short notice of the next stage. A business visit on Friday prevented me from mailing this letter then.

Of the 48 entries, 31 sets of shot cards have been returned. The full score table is attached and shows the 21 who qualify for the shoulder-to-shoulder stages at Perth on 18th May and Aberdeen on 1st June. The Ladies whose names are marked with an asterisk qualify to shoot in the Ladies team trials which run concurrently. Mrs. S. Robertson (Bon Accord) was already seeded in this group.

The trial at Perth on 18th May comprises a Double Dewar, to be shot on the three-card system with 2 details at 50 yards starting 11.00 a.m. and 2 details at 100 yards starting 2.30 p.m. A preliminary practice detail will also be available at each distance. The shoot will be in the capable hands of Miss J.M. Adamson who will also be running a sweepstake on the day's Aggregate (50 pence entry).

Similar arrangements will apply to the second part at Denwood Range, Aberdeen, on 1st June. The aggregate of the four Dewars determines the six who will join the 1975 Team Squad (and four for the Ladies squad). The Team's first match of the season is against the Army on June 21st & 22nd at Donnington, near Shrewsbury.
